ANNEX 1 : Spécifications

Scope of the work:

Supply of the Silica Sand:

Silica Sand is our key raw material for our production process. Therefore, the supply of Silica Sand should always meet our below technical specification.

- 1. Full specification of Silica Sand (medium: 0,1 to 1,2mm) Size Distribution:
 - Size Distribution should be between 0.160 mm 0.315 mm.
 - It should be dry sand with no moisture (>0.2%)

Additional notes

- To size grains, is important not to have many coarse particles (maximum 10% above 0,6mm) otherwise products will be too rough and very different from exists in the market in workability perception.
- Moisture content: 0,2% is the ideal situation; until 0,5% still possible to work.

Supply of the limestone:



Limestone is our key raw material for our production process. Therefore, the supply of limestone should always meet our below technical specification.

- 2. Full specification of limestone
 - Size Distribution should be lessthan 0.08 mm
 - The Impurity of calcium carbonate should be greater than 99% & the content of free calcium oxide (CaO) should be lesthan <0.1%.
 - The moisture content should be <0.2%

Volume of Purchase:
